- Reduction of Risk Potential (9-15%): Involves reducing the likelihood that clients will develop complications or health problems related to existing conditions, treatments, or procedures.
- Physiological Adaptation (11-17%): Focuses on managing and providing care for clients with acute, chronic, or life-threatening physical health conditions.

Quantitative Analysis of the Scoring Model
