This ensures that data remains stable throughout the system, preventing "race conditions" where different parts of a circuit update at different times, leading to unpredictable behavior.

Logic Families: TTL vs. CMOS Characteristics

In practical application, digital logic is implemented using different electronic component technologies, known as logic families. The two dominant families are **Transistor-Transistor Logic (TTL)** and **Complementary Metal-Oxide-Semiconductor (CMOS)**.
